SUBJECT: Appointment of the President of IFAD

Distinguished Heads of Organizations with Observer Status to IFAD,

In accordance with article 6, section 8(a) of the Agreement Establishing IFAD, the appointment of the President of IFAD will be considered at the first special session of the IFAD Governing Council, to be held in Rome on Thursday, 7 July 2022.

Nominations of candidates for the Presidency are put forward by IFAD Member States and must be received by the Secretary of IFAD no later than midnight, 6 May 2022, Rome time.

FORTHCOMING APPOINTMENT OF THE PRESIDENT OF IFAD, 7 JULY 2022

IFAD

1. IFAD is an international financial institution and a specialized agency of the United Nations. It was established in 1977 as a partnership of the member states of the Organisation for Economic Co-operation and Development (OECD), the Organization of the Petroleum Exporting Countries (OPEC), and other developing countries. Its membership currently comprises 177 countries.
2. IFAD's goal is to enable poor rural people to improve their food and nutrition security, increase their incomes and strengthen their resilience. It provides concessional financing to developing countries and works directly with poor rural people, including youth, women and indigenous peoples. It works in partnership with its Member States and multilateral and bilateral partners in the global effort to achieve global food and nutrition security and sustainable agriculture.
3. IFAD, like other international financial institutions, mobilizes core resources through periodic replenishments from its Member States and by mobilizing additional funding from other sources. Since 1978, it has provided about US\$23.2 billion in grants and low-interest loans to projects that have reached some 518 million people.

IFAD's President

4. Under the direction of IFAD's governing bodies, the President of IFAD is responsible for conducting the business of the Fund and for organizing its work. The President is the chairperson of the Executive Board, whose membership consists of representatives of IFAD's Member States.
5. The President of IFAD has the same rank as the elected heads of other major United Nations specialized agencies. S/he is a Member of the United Nations Chief Executives Board, which is chaired by the UN Secretary-General, and which guides the coordination of the work of the UN system as a whole.
6. The President of IFAD is appointed for four years with a two-term limit of eight years. The current President of IFAD is Mr Gilbert F. Houngbo.
7. In accordance with the Agreement Establishing IFAD, the Governing Council of IFAD will appoint a new President at a special session on 7 July 2022. The elected President will take office on 1 October 2022.
8. Nominations of candidates for the President of IFAD are put forward by Member States of the Fund and must be received by the Secretary of IFAD by midnight, 6 May 2022, Rome time.

Member States to nominate candidates for next IFAD President

Rome, 30 March 2022 – At a time when global food security is becoming a rising concern for governments around the world, the [International Fund for Agricultural Development](#) (IFAD) today announced a call to its 177 Member States to nominate candidates for the Fund’s next President.

IFAD is a specialized United Nations agency and international financial institution focused on the alleviation of rural poverty and hunger.

The President is IFAD’s most senior position with responsibility for leading the organization and chairing its Executive Board. Nominations for President can only be made by IFAD Member States and must be received by the Secretary of IFAD no later than 6 May 2022.

The President will lead IFAD at a crucial time. Fears that rising food and fuel prices - worsened by the current conflict in Ukraine - could lead to a global food crisis are running high, with the world’s poorest rural people likely to be hardest hit. Small-scale producers are already reeling from the impacts of the COVID-19 pandemic, droughts, cyclones and other natural disasters. Their incomes are expected to be affected by the rising cost of inputs, reduced food supplies and disrupted markets. This is also likely to have devastating and long-term impacts on their nutrition and food security.

IFAD plays a crucial role in increasing the resilience of rural small-scale producers to shocks, and ensuring that they can continue to grow food and earn incomes. The Fund’s investments in climate adaptation and sustainable food systems are helping to achieve the Sustainable Development Goals to eradicate hunger and poverty.

Following the nomination process, the appointment of the next President will take place on 7 July 2022 during the first special session of the IFAD Governing Council. The Governing Council is IFAD’s principle governing body with full decision-making powers.

The President of IFAD serves a four-year term, renewable once. The newly appointed President will take office on 1 October 2022.
