Recommendation for approval

The Executive Board is invited to approve the recommendation for the proposed grant as contained in paragraph 13.

I. Background and compliance with IFAD Policy on Grant Financing

- 1. The importance of secure land and resource tenure is widely acknowledged in both research and practice. Attention to women's rights is growing, spurred by evidence on the instrumental value of women's land and resource rights for a range of developmental outcomes, as well as by the demands of women's movements themselves. Access to land and resources is a critical entry point for women's empowerment. It defines social status and political power in the village, and structures relationships both within and outside the household. However, women continue to be disadvantaged by insecure property rights and access to land and natural resources and by exclusion from decision-making and governance systems at different levels, from local to national. Addressing the institutional barriers that women face the rules and norms that define how resources are governed and how people can benefit from them is essential both to achieve gender equality and to secure rights and access to land.
- 2. Innovative approaches will be needed to achieve the 2030 Agenda for Sustainable Development, including its goals of reducing gender and other social inequalities. One area in which inequalities are prevalent is that of land rights (understood here broadly as bundles of rights to access and make decisions over the use of land). In development practice and policies, interventions that have supported gender equality and land rights have not engaged effectively with the roots of inequality. Much can be done to integrate gender-transformative approaches (GTAs) into such interventions to improve land rights practices and outcomes. This programme aims to address this challenge.
- 3. The proposed programme is in line with the goal and objectives of the IFAD Policy on Grant Financing (2015). It will promote innovative, pro-poor approaches and technologies with the potential to be scaled up for greater impact and generate and share knowledge for development impact. The aim of the proposal is to promote and strengthen women's land rights (WLR) through the integration of GTAs in rural development interventions. Its strategy is based on three interactive pillars: (i) stocktaking to identify lessons, good practices and principles from existing approaches, interventions and operational experiences, and conducting gender analyses; (ii) developing and testing contextually appropriate, innovative and collaborative GTAs in seven countries; and (iii) deploying an effective, multilevel knowledge-sharing and engagement strategy to review and adapt existing approaches and tools, create an enabling environment for knowledge use, and promote cross-regional learning and scaling out of best practices at a general level. The recipient was identified through competitive selection.

II. The proposed programme

- 4. The overall goal of the programme is to promote and strengthen WLR through the integration of GTAs in rural development interventions by improving policies and implementation tools and practices in targeted countries. The objectives are to:
 - (i) To enhance the recognition and protection of WLR in targeted countries.
 - (ii) To contribute to the creation of conditions that would enable women's enjoyment of land rights over time.

- 5. The target group will be composed of 7,000 women and girls living in rural areas in the selected countries who are involved in IFAD-supported projects. About 40 per cent of them will be younger than 35 years old. Policymakers and development practitioners will benefit indirectly from the outcomes of identifying and testing tools that will be widely disseminated.
- 6. The programme will be implemented over three years and will have the following components:
 - (i) Component 1. Gender analysis and piloting tools
 - (ii) Component 2. Knowledge management to step up the GTA agenda
 - (iii) Component 3. Programme management

III. Expected outputs/outcomes

- 7. The programme will produce the following outputs
 - (i) Seven country gender analysis reports on the root causes of inequalities influencing WLR, which will inform the design and adaptation of GTAs in each country;
 - (ii) Contextually appropriate GTAs specifically addressing identified bottlenecks to WLR are developed, deployed and monitored in seven countries;
 - (iii) Local and national stakeholders are engaged in participatory processes and forums on strengthening WLR and supported by a host of targeted tools, country reports and guidelines as well as gender specialists;
 - (iv) Key stakeholders from 21 IFAD countries engaged in South-South exchange on GTAs and WLR through a global knowledge exchange workshop;
 - (v) High-level engagement workshops organized in seven countries, supported by targeted policy briefs on strengthening women's tenure security;
 - (vi) Joint capacity-building workshop organized with IFAD on integrating GTAs for WLR across its portfolio.
- 8. The programme is expected to have the following outcomes:
 - (i) Policymakers in targeted countries are aware of challenges, bottlenecks and solutions to strengthen women's tenure security;
 - (ii) Local and national stakeholders, including IFAD, have stronger capacities to propose policies and programmes that enhance WLR through GTAs;
 - (iii) Women of different ages and socio-economic groups are represented and participate actively in decisions about land at community and household levels.

IV. Implementation arrangements

9. The programme will be executed by the Center for International Forestry Research (CIFOR) together with three other CGIAR centres: World Agroforestry, the Alliance of Bioversity International and the International Center for Tropical Agriculture, and the International Food Policy Research Institute (IFPRI). CIFOR's programme management and coordination team manages and records grant agreements with funders and subcontracts with partners. At the programme level, one senior CIFOR scientist will coordinate and supervise overall management and implementation together with one senior scientist each from the Alliance and IFPRI. Programme management coordinators, who will ensure compliance of workplan activities and the logical framework (logframe), will be in close contact with IFAD programme staff to ensure alignment with the proposed logframe. Country coordinators will be responsible for coordinating implementation of gender analysis and piloting tools at the country level. Given the presence and experience of various centres working in

- the different countries, country coordinators will also be responsible for engaging local partners to support implementation activities.
- 10. CIFOR's integrated planning, monitoring, evaluation and learning strategy will be adopted, acknowledging inherent challenges in implementing, as well as monitoring and evaluating activities that aim for outcomes and impacts through knowledge generation. Regular tracking will be undertaken through joint reflection and learning, as well as participatory monitoring and evaluation, to enable beneficiaries to document and learn about changes resulting from different GTAs.
- 11. There are no deviations from the standard procedures for financial reporting and audits.

V. Indicative programme costs and financing

12. The total programme amount is US\$2.36 million, with IFAD financing amounting to US\$2 million and cofinancing to US\$360,040.
