1. **Opening of the session**

The fourth session of the Consultation on the Thirteenth Replenishment of IFAD's Resources (IFAD13) will be held on Thursday, 14 December and Friday, 15 December at the Ministry of the Economy, Finance and Industrial and Digital Sovereignty, Centre de conférences Pierre Mendès-France, 139 Rue de Bercy, 75012 Paris. The session will take place from 11 a.m. to 6 p.m. on Thursday and will continue on Friday, from 9 a.m. until approximately 6 p.m. Representatives will be invited to participate in person. Agenda items 1 to 4 are scheduled for discussion on Thursday, and agenda items 5 to 7, including the pledging session, are scheduled for discussion on Friday. Final details, including the timing of the session and various agenda items, and any additional activities taking place each day after the meeting will be communicated in due course. The session will allow for remote participation of delegates who are unable to attend in person.

3. **Report of the Consultation on the Thirteenth Replenishment of IFAD's Resources**

Management will present the final draft report, including the IFAD13 Results Management Framework, summarizing the discussions and decisions of the IFAD13 Consultation.
