# Sessions and workplan of the Consultation on the Fourteenth Replenishment of IFAD's Resources

## I. Overview

1. **Background.** Article 4, section 3, of the Agreement Establishing IFAD requires the Governing Council to periodically review the adequacy of the resources available to IFAD to ensure continuity in its operations. To allow for timely review of IFAD's resources before the period of the Thirteenth Replenishment of IFAD's Resources (IFAD13), which expires on 31 December 2027, the Executive Board reviewed and approved a draft resolution on the Establishment of the Consultation on the Fourteenth Replenishment of IFAD's Resources (IFAD14) and submitted it to the Governing Council for approval at its forty-ninth session.
2. To ensure that IFAD14 enters into effect by 1 January 2028, it was recommended that the IFAD14 Consultation sessions be held in 2026 and that the Consultation's recommendations be reported to the fiftieth session of the Governing Council in 2027. Following the launch event, three formal sessions are expected to suffice for the IFAD14 Consultation.
3. The proposed workplan has been developed in consultation with the IFAD14 External Chair, based on the feedback received at the IFAD14 pre-Consultation meeting on 11 December 2025 and through informal discussions with List Convenors and Member State representatives.
4. **Location of sessions.** The first two sessions will be held at IFAD headquarters in Rome. Should there be interest from a Member State to host the third session, IFAD will explore options. Members will be provided with details as soon as they are available. In finalizing arrangements, Management will ensure that the standard practices adopted for the replenishment processes of similar organizations are followed.
5. **Dates of sessions.** In anticipation of the adoption of this resolution, and after consultations with the List Convenors and Executive Board representatives, the President of IFAD has invited Member States to a launch event for the IFAD14 Consultation on 12 February 2026 at IFAD headquarters.
6. Consultation members are now invited to agree on the dates for the three sessions of the IFAD14 Consultation as indicated in table 1. Management may propose minor adjustments to these dates as arrangements for hosting certain sessions are finalized. In such cases, the final dates and locations will be communicated at the preceding session.

## **II. Details of proposed agenda items and papers by session**

### **A. First session (7–8 May 2026)**

#### **IFAD13 midterm review**

7. The midterm review provides an overview of the performance of the institution after the first year of implementation of IFAD13. It reports on the business model for IFAD13 and provides an update on the institution's performance against the commitments and agreed targets, highlighting areas in which progress is being made, and areas where further efforts are required, alongside plans to address them.

#### **Report on the status of contributions to IFAD13**

8. Management will provide an update on the status of contributions to IFAD13.

#### **Corporate-level evaluation (CLE) of the institutional and operational performance under IFAD11 and IFAD12**

9. The Independent Office of Evaluation of IFAD will present the findings and recommendations of its CLE of the institutional and operational performance under IFAD11 and IFAD12, and Management will present its response to the report.

#### **Zero draft Report of the Consultation on the Fourteenth Replenishment of IFAD's Resources**

10. Management will present a zero draft report reflecting the direction and decisions of the IFAD14 Consultation, building on discussions at the IFAD14 pre-Consultation and the launch of IFAD14. This report will continue to be refined throughout the Consultation. It will include a matrix of policy commitments, a results management framework, and the proposed IFAD14 financial framework.

### **B. Second session (29–30 October 2026)**

#### **Updated draft Report of the Consultation on the Fourteenth Replenishment of IFAD's Resources**

11. Management will present an updated draft report reflecting the direction and decisions of the IFAD14 Consultation. This version will include a refined matrix of policy commitments, an updated results management framework, and updates to the IFAD14 financial framework. The official IFAD14 exchange rates will also be provided.
12. In advance of this session, the draft report will be shared on IFAD's website for public comments, and feedback will be solicited from key IFAD partners. The comments received, and Management's proposals to address them, will be presented to Member States as part of the session.
13. Following the second session, an updated version of this report will be published on the Member States Interactive Platform. Member States will have the opportunity to provide comments online before the report is finalized and submitted for approval at the third session. The purpose of this final round of comments is to ensure that the paper is ready to be approved at the third session, and to allow that session to focus primarily on pledging.

#### **Draft Resolution on the Fourteenth Replenishment of IFAD's Resources**

14. Management will present a draft IFAD14 Resolution. The resolution – when finalized – will reflect the contents of the IFAD14 Report and the conditions governing IFAD14 contributions.

### **C. Third session (14–15 December 2026)**

#### **Final Report of the Consultation on the Fourteenth Replenishment of IFAD's Resources**

15. Management will present the revised IFAD14 Report, based on feedback from the second session, comments received on the Member States Interactive Platform and bilateral consultations with Member States, for agreement on submission to the Governing Council for approval.

#### **Draft Resolution on the Fourteenth Replenishment of IFAD's Resources**

16. Management will present the final draft of the IFAD14 Resolution for agreement on submission to the Governing Council for its adoption.

#### **Pledges to IFAD14**

17. Member States will be invited to announce their pledges to IFAD14.

### **III. Recommendation**

18. The Consultation is requested to:
  - (a) Provide feedback and approve the proposed sessions and workplan for the IFAD14 Consultation; and
  - (b) Authorize Management to initiate discussions about hosting certain IFAD14 sessions outside of IFAD headquarters. The final arrangements will be communicated to Consultation members no later than 7 May 2026 (the start of the first session).
