CLOSING STATEMENT BY MR LENNART BÅGE, PRESIDENT OF IFAD AND CHAIRMAN OF THE CONSULTATION ON THE SEVENTH REPLENISHMENT OF IFAD'S RESOURCES, TO THE FOURTH SESSION OF THE CONSULTATION

Distinguished Delegates,

Let me now sum up our deliberations over the past two days of this session of the Consultation.

The session began with an inaugural address by His Highness Sheikh Abdullah Bin Khalifa Al-Thani, Prime Minister of the State of Qatar, delivered on his behalf by His Excellency Dr Sultan Bin Hassan Al-Dhabit Al-Dousari, Minister for Municipal Affairs and Agriculture. Qatar was the first Member State to announce its pledge to the Seventh Replenishment of IFAD's Resources. Its generous pledge of USD 10 million represents a significant and most welcome increase from past replenishments.

Consultation Members expressed their sincere gratitude to the State of Qatar for its gracious hospitality in hosting the session and applauded the excellent organization of this session.

Under agenda item 3 on the replenishment level, the Consultation considered the work programme and financing requirements for the Seventh Replenishment period. To facilitate the Consultation's consideration of these issues, Dr Keith Bezanson presented the Consultation with an overview of the current international development context and the growth that had taken place in official development assistance flows, particularly since the adoption of the Millennium Development Goals and as a result of the Monterrey Consensus of 2002. Many Members welcomed an increased work programme during 2007-2009, noting that this would enable the Fund to reach 13 million rural poor people each year. Several Members made specific pledges while others reiterated their strong support for the Fund and indicated that they would announce their exact pledges at a subsequent date.

The presentation on the road map for implementing the action plan for management's response to the Independent External Evaluation of IFAD was welcomed by the Consultation as a helpful clarification of the plan's key components and issues. Members indicated during the discussion that the presentation had provided an improved definition of the reform process, the management of that process and the key deliverables. Some emphasized that the action plan is a necessary part of the Replenishment and asked for further clarification on what will be provided at the December session of the Consultation and how the action plan will be linked to the Report of the Consultation on the Seventh Replenishment of IFAD's Resources. In addition, they noted that the deliverables were linked to a specific time frame with decision and approval points for review by the Executive Board. Further definition and elaboration of the resources required to ensure the effectiveness and timely delivery of the change management programme would be provided at the December 2005 and April 2006 Executive Board sessions as agreed by the Executive Board in September.

With respect to agenda item 4 on the debt sustainability framework (DSF), many Members supported IFAD's adoption of such a framework but underlined the need to have a clear commitment to compensate IFAD for principal payments and service charges forgone. Members also emphasized the importance of ensuring that implementation of the framework would not have adverse consequences on the volume of financial support to DSF-eligible countries. They further asked for greater clarity of information on the relationship between the DSF and the grant programme under the IFAD Policy for Grant Financing approved by the Executive Board in December 2003 as several suggested that the Policy for Grant Financing may need to be adjusted when the DSF is adopted/implemented.

In response to a request, an update was provided to the Consultation on IFAD's participation in the Heavily Indebted Poor Countries (HIPC) Debt Initiative. In this context, Members urged the Fund to continue its efforts to gain access to the core resources of the World Bank-administered HIPC Trust Fund. We would strongly welcome your continued assistance in ensuring a successful outcome in this respect.

Under agenda item 5, the Consultation had a rich and productive discussion on the role of the Executive Board. Members emphasized the need for the Board to focus on providing strategic and policy guidance, on the one hand, and monitoring development effectiveness and efficiency, on the other. Members made a number of proposals and suggestions in this regard, and it was agreed that a summary would be made thereof for consideration by an appropriate mechanism to be established by the Executive Board in order to elaborate specific proposals, bearing in mind their cost implications.

The Consultation was presented with a document on the management of risk at IFAD, which described the management of financial and fiduciary risks by the Fund, provided information on IFAD's internal control practices (focusing on recent improvement initiatives), and outlined its approach to improving the effectiveness of such practices. Members noted the Fund's efforts to enhance the internal control systems and to finalize the IFAD Policy on Preventing Fraud and Corruption in its Activities and Operations.

Under agenda item 7, the Consultation was presented with an analysis of IFAD's current policy concerning the disclosure of documents and a comparison with the disclosure policies and procedures of selected international financial institutions and United Nations agencies. It was noted that the disclosure policy would be reviewed by the Executive Board in 2006, and that Members' comments and suggested enhancements would be incorporated in the revised policy.

The Consultation then considered the draft report of the Consultation on the Seventh Replenishment of IFAD's Resources. There were extensive discussions and Members offered many useful comments and suggestions that would be kept in mind when preparing the next draft. In particular, the document would be shorter, more action-oriented and more reader-friendly, and would

show how IFAD would change in the coming three years in response to the evolving international architecture and the implications of the Paris Declaration on Aid Effectiveness. In addition, it would focus on items for consideration by the Consultation rather than those in the remit of the Executive Board and IFAD management.

Under this agenda item, it was proposed that the issue of the performance-based allocation system should be included in the discussion on the draft Consultation report to be considered at the December session. We will be prepared to provide an information note for discussing this issue.

The Consultation was also presented with a draft resolution on the Seventh Replenishment of IFAD's Resources. A separate paper was provided that gave information regarding the exchange rates applicable for the conversion of freely convertible currency contributions into United States dollars and special drawing rights. It was agreed that a revised draft resolution would be presented at the December session containing the agreements reached by the Consultation, including asset liability management/advance commitment authority, and comments made in writing by Members. The Consultation decided to fix the six-month exchange rate reference period for the Seventh Replenishment at 1 April to 30 September 2005.

Under agenda item 10, a document was presented on the Associate Professional Officer Programme, taking into account the comments and suggestions made at the Third Session of the Consultation. While there was broad support for the concept, it was felt that further consideration was required before taking a view on this matter.

As regards agenda item 11 on the voting rights of Member States and membership of the Executive Board, it was agreed that a working group be established on this matter with the mandate agreed (see REPL.VII/4/C.R.P.1 annexed).

Finally, the Consultation approved the disclosure, on IFAD's public web site, of the documents submitted to this session.

Distinguished Delegates, we have come to the end of a very important session of the Consultation. The pledge made by the State of Qatar for a contribution to this replenishment has been, I am sure, an inspiration to all Members as they consider their contribution to the replenishment.

May I express my strong hope that Member States that have not been in a position to announce specific pledges will be able to do so in the coming weeks, in order to enable us to complete our work on schedule.

In closing, I would like to thank all of you for your active and productive participation in our deliberations. Once again, on behalf of the Consultation, I would like to offer my sincere appreciation to the State of Qatar for its most gracious hospitality in hosting the Fourth Session of the Consultation on the Seventh Replenishment of IFAD's Resources and contributing to the success of this important session.
